**BOARD AND COMMITTEE REPORTS**

**Report of the Chair**

Charter Review Commission filing — Chair reported our prospects look good for winning a balanced commission and that Norma Turner is planning to coordinate among progressive candidates who want to sign on for a good-governance advertising campaign.

Votebuilder training — 21 attended.

Program meeting — Prosecuting Attorney Will Payne spoke. Twelve attended, including several lawyers. Chair described it as an informational, straightforward presentation.

Election Observer Training at county elections office, June 24th — Chair, Ed Grier and LeRoy Martin plan to attend.

WA mend — all petitions must reach Andrea Radich by noon July 2. Committeewoman and Committeeman — not present.

**Committee Reports/Discussion**

Parades — Marcia Farrell said the summer parade dates are Joyce Aug. 2, Forks July 4, P.A. July 4, Neah Bay Aug. 22-23, Quileute/La Push July 19 and Clallam Bay July 12.

Fundraising — Marcia Farrell — Roosevelt Dinner set for Sept. 27 at Red Lion in Port Angeles. Cantwell possible guest speaker. We're also trying to contact former governor Gary Locke.

Need for a large flat-screen TV discussed briefly. Kris Grier helping. Marcia also said she wants any ideas for fundraisers.

Use of party office space, LeRoy Martin. Leroy said questions start

with key control, and who coordinates it. How do you set fees? Record keeping for responsibility in cases of theft or damage. The chair said we may need to rent only to members. We may be able to set up a card system that would record when people entered and who they were, and enable us to lock any card holder out. LeRoy said we need guidelines and he would prepare a report for the next meeting.
